



**Open Call for articles to be published in the next issue of the journal *Política Internacional* of the Diplomatic Academy of Peru Javier Pérez de Cuéllar referring to "The growing role of non-state actors in international relations (particularly in the multilateral sphere), as well as their impact on the nation-state system and its effects on the dynamics, both between and within states."**

1. The Diplomatic Academy of Peru Javier Pérez de Cuéllar (ADP) cordially invites all diplomatic officials (active and retired), academics, national and foreign specialists, and postgraduate students to submit articles for consideration for publication in the 132<sup>nd</sup> Edition of the journal "*Política Internacional*" (International Politics) 2022- II.
2. The theme of this issue will be "*The growing role of non-state actors in international relations (particularly in the multilateral sphere), as well as their impact on the nation-state system and its effects on the dynamics, both between and within states*", from a perspective that participants consider relevant to countries such as Peru and Latin America in general.

As transactions between individuals, societies and countries intensify and as transnational interactions become increasingly complex, non-state actors have emerged that have the capacity to contribute to and shape (for better or worse) the international agenda.

Non-state actors have a growing capacity to influence decision-making processes at the state level on various issues such as: environmental protection, security, technology, human rights, health, development, drug trafficking, religious movements, indigenous peoples, among others.

Articles may address the participation and influence in international relations of traditional non-state actors such as NGOs and multinational companies as well as more recent actors, including Big Tech (Meta, Apple, Amazon, Huawei, etc.), philanthropic organizations (Bill and Melinda Gates Foundation, Wellcome Trust, Novo Nordisk Foundation, etc.), hackers (Anonymous), terrorist groups (Al – Qaeda, ISIS), etc.; which in some cases have greater power and resources than the states themselves, and with the capacity to be disruptive in the international scenario.

3. The articles must be original, unpublished, and exclusive.
4. Articles will be received in Spanish and English.
5. The articles submitted will be submitted to an anonymous arbitration by academic experts in the field appointed by the Diplomatic Academy of Perú (ADP), who will evaluate the feasibility of publishing the articles.
6. The ADP will inform the authors about the outcome of the anonymous arbitration. When the evaluators recommend that the text be publishable with modifications, the author must make the changes so that the article is published in the journal "Política Internacional".
7. The articles will be presented in compliance with the following format:
  - Title
  - Name of the author and brief updated professional review as footer (maximum 140 words).
  - Abstract in Spanish and English
  - List of keywords in Spanish and English
  - Letter Arial 12
  - Space 1.5
  - Bibliographic references using APA standards, seventh edition
  - Bibliography at the end of the article
  - The maximum length (not including bibliography) is 6,500 words

8. Only those articles that meet the form requirements referred to in point 7 will move to the anonymous arbitration stage (point 6).

The message must include the telephone contact of the authors and the subject will be "Article journal International Politics" and must clearly indicate the full name of the participant and the title of the article.
