## Notice to Candidates

**Cheat, copy, help another candidate** during the test.

**Talk to, try to communicate with, or disturb** other candidates during the test.

**Use** offensive language.

**Attempt to** move away from the test window or use any other electronic devices or access unauthorised material/websites.

**Smoke, vape, eat, or drink** (except water) in the test room.

**Leave the test room** for any reason without the permission of the invigilator.

**Take any rough paper** out of the test room.

**Make any noise** in or near the test room.

During the test you will be monitored by a centre invigilator with the support of Artificial Intelligence (AI) invigilation. The test will be recorded. Using the computer's webcam, the AI invigilation service will take your photo.

- Cambridge English Skills Test Business (16+ yrs)
- Cambridge English Skills Test Schools (secondary) (12-15yrs).

# Cambridge English Skills Test

By entering and using the Cambridge English Test Portal (Metrica) and any other websites notified to the Candidate as part of registration, the You agree to be bound by these Terms and Conditions and regulations under which the Cambridge English Skills Tests are provided.

## 1. By registering for the Cambridge English Skills Test, you agree and acknowledge that:

- 1.1 You may only register for a Cambridge English Skills Test through an approved Institution or Client/ School who will be able to provide you with details such as the test date, invigilation method and test fees.
- 1.2 An Institution or a Client/ School, as may be applicable, may decide whether or not to accept a registration. Once Your registration has been confirmed, you may not transfer Your entry to another Institution.
- 1.3 The Test content of the Cambridge English Skills Test General and Business (16+yrs) is designed for adult English language learners, and the Test content of the Cambridge English Skills Test Schools (secondary) is designed for 12 to 15-year-olds.
- 1.4 When purchasing an entry to take the Test either from an Institution or from a Client/ School and any payment of test fees is a matter between you and the Institution or Client/ School as may be applicable. Fees may vary from region to region, depending on variations in local costs.
- 1.5 You agree and acknowledge that the Test is a modular test and you may take any combination of the modules subject to these modules being run and administered on your selected date.
- 1.6 The Cambridge English Skills Test General and Business (16+ yrs) uses an Artificial intelligence (AI) invigilation service in addition to face-to-face invigilation for Institution or Client/School, and an AI invigilation service if the Tests are to be taken remotely. The AI invigilation service uses video/image data, audio and event logs for the purpose of assessing test security. All data will be processed in accordance with our privacy policy and all recordings will be retained for 6 months.  
  
AI and remote invigilation is not applicable for the Cambridge English Skills Test Schools.
- 1.7 Your responses to the Speaking test will be recorded and are kept for the purpose of result assessment and validation and product research and development.
- 1.8 Any failure to comply or breach of these Regulations may result in your entry for the Test being cancelled without any refund of fees and/or Your Test result being permanently withheld.
- 1.9 If you require and are eligible for access arrangements including extra time, online modified adaptive Listening and Reading version or off-line modified papers, you must inform your Institution or Client/ School as soon as possible in order that they can pass the relevant details to us so we can put the necessary arrangements in place. You acknowledge that access arrangement versions taken **online** and including extra time need to be made **five days** before the Test is taken. Any requests for **offline** paper-based versions must be made at least **three (3) weeks** before your intended Test date.
- 1.10 In the event that You are unable to take the Test due to illness, injury, or exceptional circumstances, you must inform your Institution or your Client/ School of this immediately. They may provide an alternative test date or offer a full or partial refund of the fee. Requests for refunds for other reasons will only be considered in exceptional cases.
- 1.11 The undertaking of the Test requires uninterrupted access to the internet, power supply and devices or services that are not owned or controlled by Cambridge English. Cambridge English has no control over and assumes no responsibility for such access, devices, or services. Cambridge will not be responsible or liable, directly, or indirectly, for any damage or loss caused or alleged to be caused by or in connection with use of or reliance on any such access, devices, or services.

## 2 Candidate Verification

- 2.1 Only the individual who registered for the Cambridge English Skills Test can take the Test. If any staff at the Institution, or the Client/ School, has any uncertainty or is unable to verify a Candidate's identity, the Candidate will not be allowed to take the Test.

## 3 Taking the Cambridge English Skills Test

### Electronic Items

- 3.1 You must not keep watches or any electronic items, such as mobile phones, recording devices, audio/video players, smart watches, etc. in the test venue during the Test. The exception is where such an item or device is needed for medical reasons or where the use of such an item or device has been notified to and approved by the Institution or Client/School before the Test.

### Starting the test

- 3.2 For in centre Tests, you must aim to arrive at the Test venue before the scheduled Test start time. Please check with your Institution or Client/ School the Test Venue details and the time when you should arrive for your Test as some Institutions may not accept late arrivals to the Test or provide a refund in the event that you arrive late.
- 3.3 For in centre Tests, you must leave all personal belongings in the designated belongings area. Please check this with your Institution or Client/School and they will be able to confirm any items that you may bring with you to the test venue. All electronic devices, including mobile phones and watches, are not permitted in the test room.
- 3.4 If you are taking the Cambridge English Skills Test General and Business (16+ yrs) remotely, please be advised that the remote invigilation process will be provided to you by the Institution or the Client/ School. including technical and hardware requirements, the test environment, the scheduled test time and items permitted when taking the test. All electronic devices, including mobile phones and watches, are not permitted in the test room when taking the Test remotely.
- 3.5 When entering your login information to start the Test on the Cambridge English Test Portal You must carefully check and/or enter information in the Candidate Information Screen. Please check for any incorrect spellings and inform your Institution or Client/ School of any errors or corrections.
- 3.6 You may be asked to provide information which will be used as part of Cambridge English's research programme to improve the quality of the Cambridge English Skills Test. Any information you provide shall be treated anonymously and kept strictly confidential.
- 3.7 You must use the same username across the different components or variants of the Cambridge English Skills Test so that the Cambridge English Test Portal, Metrica can link Your accounts and produce Your Results Report and provide results across all skills.
- 3.8 Some key rules and regulations on what candidates can and cannot do during the Cambridge English Skills Test are provided in the Notice to Candidates.
- 3.9 You must inform the invigilator immediately if there any issues with the equipment for example if the headphones or microphone are not working or if the correct test is not displaying, is incomplete or unreadable on the computer screen.
- 3.10 You must raise your hand if you need to ask any questions to the invigilator. You may not ask for any explanation of the test questions as this will not be given.
- 3.11 You must not:
- talk to or disturb other Candidates once the test has started
  - lend anything to, or borrow anything from, another candidate during the Test
  - eat, smoke or vape in the Test Venue
  - use offensive language such as rude or racist language
  - leave the test room without the permission of the invigilator
  - leave the test room at the end of the test unless instructed by the invigilator
  - have any items which are not allowed in the test room, including mobile phones or any other electronic items
  - engage in any form of malpractice which may damage the integrity and security of the Test. Further information on Malpractice can be found in section 4.
- 3.12 You acknowledge and agree that if you are completing the Speaking test, your answers will be recorded.

## **4 Malpractice**

- 4.1 Any Candidates who do not comply with these Terms and Conditions, instructions from Cambridge, the Institution or Client/ School, or by invigilators or whose behaviour is disruptive, may be stopped from taking the Test or may be subject to Cambridge English Malpractice procedures.
- 4.2 Malpractice includes but is not limited to:
- obtaining unauthorised access to Test material
  - attempting to obtain an unfair advantage (cheating or deception) in any way, including using or trying to use unauthorised material or websites
  - copying/collusion or attempted copying/collusion with others
  - disruptive behaviour or not following the instructions of test administrators including the use of prohibited devices
  - impersonation, pretending to be someone else or having somebody impersonate the Candidate
  - copying the work of another Candidate
  - disrupting the Test in any way
  - reproducing the Test or any part of it in any medium including memorising the Test material to gain or give an unfair advantage
  - altering or attempting to alter the data on the Results Report or any results document; or
  - any other form of cheating or gaining of an unfair advantage.
- 4.3 Malpractice is likely to be detected and reported by the invigilator. It may also be detected by an AI invigilation service (Cambridge English Skills Test General & Business (16+ yrs) only), examiners during marking and by other checks applied by Cambridge to Candidates' answers, as required.
- 4.4 A candidate will not receive a result if they are found to have been involved in malpractice or where Cambridge English does not consider the scores to be a reliable indicator of their ability. Cambridge English reserves the right to cancel Cambridge English Skills Test results for the entire test session, if it considers their rules and regulations were breached for any of the modules and/or the scores are not valid due to malpractice. As this is an institutional test, there is no appeal service and candidates should raise their concern with their test Institution or Client/School of the Institution.
- 4.5 Candidates are not entitled to a refund if their results are cancelled or withheld due to malpractice.
- 4.6 Cambridge English may share the outcomes of test security investigations and information about candidates whose results have been cancelled with institutions, parents/guardians, government agencies, or law enforcement.
- 4.7 Cambridge English welcomes legitimate reports of suspected fraud, malpractice, misconduct, suspicious activity, and threats to the security or integrity of the Cambridge English Skills Test. If you believe you have witnessed, suspect or are aware of any reportable matters, you must report this to Cambridge English immediately using this [LINK](#).

## **5 Results and Result Reports**

- 5.1 Cambridge English will endeavour to issue a Candidate's Test result to the institution via the Cambridge English Test Portal within at least 48 hours of the Candidate taking the Cambridge English Skills Test, unless informed otherwise.
- 5.2 A Candidate's Test result may not be issued if an Institution or Client/School has disqualified a Test result or if in Cambridge's reasonable opinion it is necessary to review and investigate any matter associated with the undertaking or administration of the Test.
- 5.3 A Candidate's Test result may be cancelled after it has been issued if any irregularity is subsequently identified.
- 5.4 Where an institution selects to allow candidates to view their results and download their Results Report this can be done by the candidate logging back into the Cambridge English Test Portal (Metrica) with their username, password and Institutional ID number. Where this has not been permitted the institution will provide the candidate results and results report to the candidate.
- 5.5 For a candidate to access and see their results for multiple tests, taken over various test dates, the candidate is required to take all the tests under the same institution, with the same Institutional/centre number. Where a

candidate takes the Cambridge English Skills Test at other Institutions a separate candidate account will be created which is associated with that Institution.

- 5.6 The Results Report will include the following details:
- the Candidate name
  - the Candidate username
  - the Institution name
  - The School/Client account name
  - the Cambridge English Scale score for each skill tested
  - the Common European Framework of Reference (CEFR) Level for each skill tested – the CEFR is the international benchmark for describing language ability
  - an average Cambridge English Scale score and associated CEFR level
  - an explanation of what each score means in terms of English language ability.
- 5.7 If any of the data on the Results Report has been altered in any way, the original test result will be cancelled.
- 5.8 Name amendments are allowed under certain circumstances. For further information, see [cambridgeenglish.org](https://cambridgeenglish.org).
- 5.9 Feedback on individual performance is not provided. All available information is provided in the Results Report and on the Results dashboard. No further information will be given to a candidate or the Institution or Client/School of the Institution. Under no circumstances will Cambridge English provide access to test responses submitted by the candidate.
- 5.10 Cambridge English may amend candidate results under exceptional circumstances. Cambridge English reserves the right to cancel the Cambridge English Skills Test results for the entire test if it considers the scores for any part are not valid.
- 5.11 The Reading and Listening modules, which are computer-adaptive, provide highly reliable test scores. Regular checks are done to maintain this high level of test reliability. The Writing and Speaking tests adopt a hybrid approach to marking in which candidates' responses are marked by either an auto-marker or human examiners. Auto-marking refers to using technology without any human involvement. For further information on the auto-marking process please see our website [here](#). Our qualified Cambridge English Skills Test examiners are subject to a rigorous training and monitoring programme.
- 5.12 If a candidate believes that Cambridge English has awarded an incorrect result for their Speaking or Writing test, which are hybrid marked and where the test was 100% auto-marked, Cambridge will request an Examiner remark of the test Results for free. This constitutes the candidate's right to request a human review of a 100% auto-marked test.
- Test Credits will be fully refunded in the unlikely event that Cambridge English changes the CEFR level of the test. Candidates should be aware that if a fault in marking is identified, the final test score may increase or decrease.
- 5.13 A candidate can re-sit any component for the Cambridge English Skills Test. They can do this immediately, or after having studied further. For the result of the re-sit to be linked to the original test, it *must* be taken with the same username and at the same Institution, with the same centre number, where the original test was taken.
- 5.15 Candidates may choose to re-sit a component(s) to improve their score. This means that they do not have to practise all four skills again and can concentrate solely on improving the skills they need. If the score does improve then this will be shown in My Best Score.
- 5.17 Test results are available via the Cambridge English Test Portal, Metrica, for a period of five years from the date of the Test.
- 5.18 Any issues, concerns or complaints relating to the delivery of the test, can be submitted. All complaints will be dealt with in line with our Complaints Policy available on [cambridgeenglish.org/help/complaints](https://cambridgeenglish.org/help/complaints).

## 6 Privacy and Personal Data

- 6.1 Cambridge English recognises and supports the right of candidates to privacy and will not use any Candidate's personal data for any purpose other than in accordance with these Terms and as described in our Privacy Policy below.
